REGISTRATION PACKET

This packet contains the following official HOA forms: (1) Owner Registration Form; (2) Tenant Self-Registration Form; and (3) Addendums 1, 2, 3, and 4 to be submitted with either official registration form. Registration with the HOA is mandatory under Chapter 2 of the HOA's Rules and Regulations adopted October 8, 2020.

REGISTRATION INSTRUCTIONS

OFFICIAL OWNER REGISTRATION FORM

Unit owners must use this form to register as a member of the Cottonwood Ridge Homeowners Association. Additionally, owners must complete all relevant registration addendums to register their vehicles parked in the complex (Addendum 2), their pets kept inside their unit (Addendum 3), and any guests who frequently visit and stay in their unit (Addendum 4). If you rent out your unit to tenants, complete Addendum 1 below. If you are a tenant who needs to register, see the tenant self-registration form below.

ADDENDUM 1 – TENANT REGISTRATION FORM

Owners who rent their unit must complete Addendum 1 and submit it to the HOA to register their tenants. A new Addendum 1 is required for each new tenant or tenancy term. Additionally, if relevant, owners must also complete all of the relevant registration addendums to register their tenants' vehicles parked within the complex (Addendum 2), their tenants' pets kept in their unit (Addendum 3), and any of their tenants' guests who frequently visit and stay in their unit (Addendum 4).

ADDENDUM 2 – VEHICLE REGISTRATION FORM

All vehicles parked within the complex must be registered with the HOA. Parking passes will not be issued without completed registration forms on file. You must update this form when you have a new vehicle parked in the complex.

ADDENDUM 3 – PET REGISTRATION FORM

All pets kept inside a unit must be registered with the HOA. Complete and submit Addendum 3 to register your pets with the HOA. Update this form when new pets or service animals are brought into your unit.

ADDENDUM 4 – LONG-TERM AND REGULAR OCCUPANT REGISTRATION FORM

All residents must register any long-term or regular guests who come to their unit as defined under the Rules and Regulations. Use this form to register family, friends, persons with whom you are in dating relationship, and any other guests who regularly visit or stay with you inside your unit.

OFFICIAL TENANT SELF-REGISTRATION FORM

If you are a tenant and your landlord will not register you with the HOA, then you may be able to use the Official Tenant Self-Registration Form to register yourself. However, for a tenant to self-register, the tenant must do the following: (1) first attempt to contact your landlord and ask them to register you and be prepared to explain why the landlord has not done so; (2) provide a copy of your state-issued photo ID; and (3) provide a copy of your written lease agreement. Otherwise, you cannot self-register. Tenants who self-register must also register their vehicles (Addendum 2), their pets (Addendum 3), and any guests who frequently visit and stay in you unit (Addendum 4).
